# 1. Objective of the Karnataka Skill Development Authority

The four objectives to

- 1) Evolve norms and policies
- 2) to establish quality standards
- 3) encourage innovation in Skill Development and
- 4) Co-ordinate with all stake holder in skill development

## 2. Functions of the Karnataka Skill Development Authority

- 1. To lay down norms and standards for curriculum, courses, content and credit framework for Skill training for various job roles, in conformity with NSQF.
- 2. To approve guidelines for recognition of assessment and certification agencies and to lay down standards of assessment and certification of trainees.
- 3. To approve suitable performance appraisal system for TPs, TCs and assessment agencies to enforce accountability.
- 4. To lay guidelines for Training of Trainers.
- 5. To undertake periodic studies relating to skill gap in various sectors, to forecast future skill requirements, to undertake research in Skills, and to promote innovation.
- 6. To recommend appropriate skill-based programmes in schools, colleges, technical institutions and universities.
- 7. To develop a State Skill Policy.
- 8. To fix norms and guidelines for charging of fees for Skill programmes.
- 9. To facilitate setting up of a State Skill University, State-level Skill Academy and Skill parks.
- 10.To promote Traditional Skills of Karnataka.
- 11.To facilitate recognition of prior learning (RPL)
- 12.To coordinate with industry, academia, Sector Skill Councils, and other stakeholders.

- 13.Collaborate with national and global institutions for improving the scope and quality of programmes.
- 14.To encourage extensive and intensive use of digital technology to improve effectiveness of the programmes.
- 15.To take up any other activities that may be necessary, to fulfil the objectives of Karnataka Skill Development Authority.
