## EXPRESSION OF INTEREST

The Government of Karnataka has proposed to impart mobile training programme under Chief Minister Kaushalya Karnataka Yojana (CMKKY) for the year 2018-19 in 8 districts i.e. Belagavi, Mysore, Kalburigi, Chitradurga, Tumakur, Dharwad, Mangalore and Bellary in the following job roles i.e. Beauty and Wellness, Retail Garments and IT & TEs. The interested mobile training providers may submit their proposals, **on or before 27-01-2019 before 4.00 PM.** subject to the following terms and conditions.

### Terms and conditions for implementation:

1) The total target per MTC per year would be 48000 hours. The breakup of this target and cost of per hour training is as follows:

1	Quick Training (QT) upto 50 Hours.	24000	60.00
2	Recognition of Prior Learning (RPL)/ Prior Learning Certification (PLC) for 6 Hours.	10000	40.00

4	IEC on SDEL	4000	-

2) The cost per hour per trainee includes IEC mobilisation, Curriculum, Training of trainers, Equipment Amortisation, Teaching Aids, Connectivity, Infrastructure, Consumables, Travel Salary of trainers and driver etc.

3) Evaluation assessment and certification for the QT, RPL, PLC and CAT would be done through a system devised by KSDA.

4) The Kaushalya Ratha will also carry out IEC activities to popularise skilling, kaushalkar.com RGCY, NRLM, Job Mela and CMKKY as well counselling and Aptitude Evaluation Test (CAT).

5) The placement and self-employment target should be 50% of the trained candidates for QT and RPL / PLC no target for CAT.

6) The minimum capacity of mobile training vehicle or centre would be 7 seater and maximum may be 15 seater in job roles with less than 50 hours of training requirement.

7) The accreditation norms shall be modified to provide suitable weight age for vehicles as Training Centre. Accreditation guidelines to be incorporated.

8) Mobile Training Providers (MTPs) must own / lease the vehicles prefabricated and fitted with the following.

**i)** Genset, **ii)** LED / LCD / Screen / TV, **iii)** Dongle based Internet Connectivity, **iv)** Adequate Lighting and Ventilation, **v)** Trainee Seating and Training Desks, **vi)** Computer / Laptops with peripherals, **vii)** Audio Visual Aids, **viii)** Training Equipment for the selected trades, **ix)** Suitable Biometric Attendance Device (may be portable), **x)** VTU i.e. GPS based Vehicle Tracking Unit.

All other terms and conditions applicable in addition to the Government Order / Guidelines issued from time to time.
